This application will need to be completed on paper and submitted to St. Francis de Sales School.	Families are responsible for remainder of tuition/fees after scholarship
Jon Peterson (State-funded scholarships awarded to students with a qualifying disability)	Complete all paperwork required by the Ohio Department of Education and submit to Intervention Specialist at SFS. Qualifying documents must be submitted prior to the application process for acceptance to St. Francis de Sales School.
